### **Educational Conference**

### "There's No Such Thing as Multi-Peopling!"©

Leaders at all levels in today's Juvenile Justice system **must** be able to multi-task, juggle priorities, and keep "all the balls in the air". But unfortunately, in the quest for efficiency, it has become all too easy to inadvertently foster the very conditions which people find most frustrating: misunderstandings, disengaged employees, lack of motivation, and interpersonal friction. As Juvenile Justice leaders prepare to bequeath their roles and responsibilities, it has never been more critical to interact effectively – with peers, employees, and citizen customers to cultivate productive relationships, and to acquire and maintain the valuable Social Capital that is the all-important currency of public service organizations.

### **Motivational Interviewing**

This training is a skill-based strengths training that focuses on skill-building for direct practice staff working with challenging clients, students, parents and families. The modules presented will utilizing multimedia presentations, interactive lecture, and facilitated small and large group exercises. A mixture of small group discussions, videos, case scenarios and full room exercises keep the training pace lively and engaging. The emphasis for this training through all the modules is on skill-building and "theory-to-practice" group work for direct application of these various curriculums.

### Juvenile Justice Courtroom Skills

This session is designed to provide basic courtroom skills in delinquency cases. The primary focus will be on the practical and legal aspects of report writing, petition writing, rules of evidence and testifying in court. Participants will learn how to write petitions, prepare reports for court, present effective courtroom testimony and handle defense cross-examination. Additionally, service of process and courtroom decorum will be covered. This workshop is designed for newer DJOs, but would also apply to other juvenile justice professionals who prepare for and testify in court.

### Girl Matters™: Thinking Beyond Pink! And Savvy Sisters

This workshop is designed to introduce administrators, counselors, juvenile justice professionals, educators and direct care staff to the fundamentals of gender responsive programming in the context of what *matters* to girls. Professionals will be challenged to create and sustain a gender responsive culture that values girls and that is designed to heal trauma, empower, and improve outcomes. The following topics will be explored and specific treatment and care management strategies will be outlined to address the "Girl Matters" topics: Safety, Identify, Communication, Relationships, Emotions (trauma and drama) and Social supports. The SAVVY model is designed to inform, provide healthy choices, shared power and positive options aimed at creating safe, healthy productive futures for girls. This workshop will review the SAVVY Sister model components: (I) SAVVY Sister Curriculum (group/individual counseling lesson plans); (2) SAVVY Treatment and Care Management Services; (3) SAVVY Positive Performance to challenge professionals to rethink their level systems/behavior management systems through a gender lens. Participants will leave the workshop with a detailed strategy for implementation.

### **School-to-Prison Pipeline**

The school-to-prison pipeline refers to the national trend of criminalizing, rather than educating, our nation's children by pushing them out of school and into the criminal justice system. Statistics show that these practices disproportionately target youth of color and youth with disabilities. Students are sent directly into the pipeline through zero tolerance policies. Students are indirectly pushed towards the criminal justice system by excluding them from school through suspension, expulsion, discouragement and high stakes testing requirements. Unconscious, unintended or "implicit" bias can distort perceptions of risk and delinquency, influencing how and what people see, how they interpret reports, and the language they use to describe others. Participants will learn strategies for reducing school referrals to the juvenile office, and other best practices from around the country.

### From St. Louis

I-70 West to Kingdom City. Hwy 54 through lefferson City to Lake Ozark (about 45 miles from Jefferson City to Lake Ozark). Turn right at second stoplight on to Business Hwy 54/ Bagnell Dam Boulevard. The Resort at Port Arrowhead is approximately 1/4 mile on your left.

### From Columbia

Hwy 63 South to Jefferson City. Hwy 54 West to Lake Ozark. Turn right at second stoplight and follow Business Hwy 54/Bagnell dam Boulevard 1/4 mile to the hotel.

### From Kansas City

I-70 East to Hwy 65 South to Sedalia. Hwy 50 Each to Tipton. Turn right at stoplight and take South Hwy 5 to East Hwy 52 and follow to Eldon. Turn right at McDonald's and follow to Hwy 54 West and on to Lake Ozark. Turn right at second stoplight onto Business Hwy 54/Bagnell Dam Boulevard.
